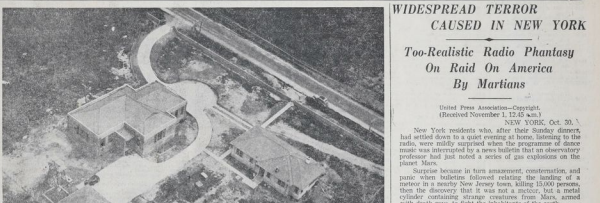

Case For The Crown Concluded

The trial of Colin Herbert Hercock, charged with the murder of Isabel Aves at Wairoa on the night of October 2, was opened in the Supreme Court yesterday, before the Chief Justice (Sir Miles Myers). Hercock, who is a prisoner of the Government, pleaded guilty to the murder of Mrs. I. A. Aves on the night of October 2, 1937.

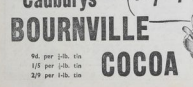
